## INFORMED CONSENT OF PARTICIPATION IN EUROTRIAL FINLAND 2019

1. That we have read, understood and accepted in full the Official Rules of the "EUROTRIAL" sports event that is published on the official website of the Championship (eurotrial.eu) and that we are fully in agreement with it, submitting to the authority of the organization of the race.
2. The race will take place in Raisio Motorsport Area 9<sup>th</sup>-11<sup>th</sup> of August. Address: Palovuorentie 147, Raisio
3. The participation in the race is under the responsibility and own risk of each participant. We declare to have undergone a medical examination, not suffering from illnesses that prevent us from taking part in it, being in perfect health to participate in the race.

That if it were not so and it was concealed intentionally or in a fraudulent way to the Sports Club or to the Organization by the pilot or co-pilot, IT WILL DENY the registration in the race because it does not meet the minimum physical conditions required and always in order to maintain safety and not increase the risk inherent in the activity itself.

4. That we have been informed sufficiently and in a comprehensible language about the characteristics of the sports activity in which we are going to participate and about the physical conditions required for such participation.
5. That we voluntarily assume the risks of the activity and, consequently, exempt the Sports Club from any damage or injury we may suffer in the development of the event. This exemption does not include the damages and losses that are the result of fault or gross negligence of the organizers.
6. The Organization declines all responsibility in case of accident or negligence of the driver or co-driver, as well as the loss or breakage of the vehicle and personal belongings of each participant. Each team will be responsible for any damage or injury that may be caused to himself or to third parties, exonerating the Organization from any liability in the event of an accident.
7. The signature of this consent implies that we authorize the organization, to the total or partial recording of their participation in it, giving our consent so they can use the images of the event for the promotion and dissemination of the image of the proof in all its forms (radio, press, video, photo, DVD, internet, posters, media, etc.) and gives all rights related to commercial exploitation and advertising that they deem appropriate to execute, without right on their part to receive any financial compensation
